

# Pandox EPRA-reporting 2024

# **EPRA** performance measures

Pandox AB reports sustainability measures for all EPRA indicators; sBPR Performance Measures. Key figures are reported for energy, Greenhouse gas emissions, water, waste, the proportion of environmentally certified buildings, as well as corporate governance and social aspects according to the latest guidelines from EPRA; sBPR fourth version April 2024.

Energy consumption is reported in MWh, Greenhouse gas emissions through direct and indirect in tons CO2e, water consumption in m<sup>3</sup>, and waste amount in tons. Intensity is reported as follows: energy intensity in kWh/m<sup>2</sup> and kWh/guest night (GN), emission intensity CO2e/m<sup>2</sup>, waste in kg/GN, and finally water intensity liters/m<sup>2</sup> and liters/GN.

# **EPRA** Overarching Recommendations

# Organisational boundaries:

The sustainability report has been prepared at a consolidated level with the same scope as the financial reporting. Pandox reports data based on two segments, Own Operations and Leases. Pandox's climate calculations are based on the GHG protocol and are consolidated and compiled based on operational control. In addition, Pandox reports a supplementary scope (referred to as "consolidated like-for-like scope") for E1 energy and emissions, E2 water, and E5 waste. The difference compared to the financial consolidation in these outcomes is that hotel property data and climate data are included in the calculations until the day they are reclassified, divested, or closed for renovation. Reclassification means a change in a hotel's operating form, where it transitions from Own Operations to Leases, or from Leases to Own Operations. The guideline is to exclude full-year data for hotels that have been reclassified, closed, divested, or acquired for more than six months.

# Coverage:

# Consolidated outcome Like-for-like

Pandox reports data on 20 fastigheter with a total area of  $365,700 \text{ m}^2$  in Own Operations, and 135 properties with a total area of  $1,642,786 \text{ m}^2$  in Leases.

# Consolidated outcome (aligned with financial report)

Pandox reports data on 24 properties with a total area of 401,316 m<sup>2</sup> in Own Operations, and 138 properties with a total area of 1,680,520 m<sup>2</sup> in Leases.



### Estimation of landlord-obtained utility consumption:

Estimates are used for energy and water consumption in the Leases segment in cases where actual outcomes are not available. The breakdown of actual vs. estimated usage is presented in the report for each area, see page 112 for energy and page 119 for water in Pandox's Annual and Sustainability Report 2024.

#### Third party Assurance:

Pandox's sustainability report has been reviewed by the company's auditors in accordance with RevR19 "Limited Review of the Statutory Sustainability Report". See the auditor's report on pages 186-187 in Pandox's Annual and Sustainability Report 2024.

#### Boundaries – reporting on landlord and tenant utility consumption:

Pandox collects and reports energy and water consumption from tenants. In cases where data is not available, it is estimated in accordance with Pandox's accounting principles for estimates. Energy consumption from tenants generates emissions in Scope 3 category 13 and is therefore an area over which Pandox has less control. Pandox reports energy and water consumption divided into the segments Own Operations and Lease Agreements on pages 111-112 and 119 in Pandox's Annual and Sustainability Report 2024.

#### Normalisation:

Pandox reports intensity based on total values per segment divided by square meters and guest nights for energy consumption, water, and waste, which is reported in the like-for-like outcome.

#### Segmental analysis:

Pandox reports sustainability data according to the property type hotel properties. The reporting is divided into two segments, Own Operations and Leases, where Own Operations refers to Pandox's own hotel operations and Leases refer to the hotel properties that Pandox leases out and therefore has less control over.

#### Disclosures of own offices:

Pandox's headquarters constitute only a small part of the total and are therefore not separately reported but are included in Own Operations for environmental data. However, they are separately reported for social data as headquarters and property management.

#### Narrative on performance:

In analyses of changes, Pandox considers any changes in the portfolio or parameters such as guest nights, where the intensity in relation to guest nights is presented in the



report. For a more detailed analysis of developments in each area, Own Operations and Leases, see Pandox's annual and sustainability report on pages 92-137.

#### Reporting period:

Pandox's accounting follows the calendar year, January 1 to December 31. Pandox reports outcomes for the last two years as well as the base year for the Science Based Targets for Scope 1, 2, and 3.

#### Materiality:

Pandox reports in accordance with CSRD, and the materiality analysis is conducted according to the guidelines in CSRD and the associated ESRS for the double materiality analysis (DMA). The outcome and method of the DMA are reported on pages 97-99 in the report.
